Environmental

Through innovative technologies, resource efficiency, and robust data management, we are committed to reducing the environmental impact of our operations and reporting our progress every step of the way.

- We have made the commitment to reduce our Scope 1 and 2 greenhouse gas emissions by 50% by 2030
- We are committed to reducing the power usage and footprint of our products, while continuing to support increasing bandwidth requirements
- We improved our CDP rating in 2022 to B-
- We improved our Responsible Business Alliance (RBA) risk rating from 83% to 88.2% in 2022 (low-risk)

Diversity, Equity, and Inclusion

Our diversity, equity, and inclusion (DE&I) strategy enables engagement and prioritizes education to provide employees with a non-discriminatory work environment that promotes open and honest communication and embraces dignity, respect, and teamwork in all aspects of our operations.

- Our DE&I program was launched in 2020
- Our mentorship program was piloted by our Women in Infinera employee resource group in 2021 and scaled company-wide in 2022
- We have increased spending with diverse suppliers, including small businesses and women-, minority-, and veteran-owned businesses

Health and Safety

We are committed to providing our workers with a healthy and safe work environment by preventing accidents, improving workplace conditions, expanding our processes, and encouraging a safety-first culture.

- We improved our environmental, health, and safety (EHS) injury rate to below industry average in 2022
- We have an automated, job-dependent EHS training program
- We offer monthly wellness webinars

Governance

In our global operations and throughout our supply chain, we strive to uphold a high standard of environmental stewardship and social responsibility, fostering a culture of ethical decision making and mutual respect.

- We have an active Global Environmental, Social, and Governance (ESG) work group focused on achieving our ESG goals and objectives
- We are a member of Responsible Minerals Initiative (RMI)
- We have 90% of our supply chain partners participating in the EcoVadis Program for Suppliers to manage sustainability throughout the supply chain
