



VERIFICATION OPINION DECLARATION GREENHOUSE GAS EMISSIONS AND ELECTRICITY CONSUMPTION

To: The Stakeholders of Toast, Inc.

Apex Companies, LLC (Apex) was engaged to conduct an independent verification of the greenhouse gas (GHG) emissions and electricity consumption data reported by Toast, Inc. (Toast) for the period stated below. This verification opinion declaration applies to the related information included within the scope of work described below.

The determination of the GHG emissions and electricity consumption data is the sole responsibility of Toast. Toast is responsible for the preparation and fair presentation of the GHG emissions and electricity consumption data statement in accordance with the criteria. Apex's sole responsibility was to provide independent verification on the accuracy of the GHG emissions and electricity consumption data reported and on the underlying systems and processes used to collect, analyze and review the information. Apex is responsible for expressing an opinion on the GHG emissions and electricity consumption statement based on the verification. Verification activities applied in a limited level of assurance verification are less extensive in nature, timing, and extent than in a reasonable level of assurance verification.

Boundaries of the reporting company GHG emissions and electricity consumption data covered by the verification:

- Operational Control
- Worldwide
- Exclusions: Co-working spaces occupied by Toast employees (based on operational control)

Types of GHGs: CO₂, N₂O, CH₄, HFCs

Data and information supporting the Scope 1 and Scope 2 GHG emissions and electricity consumption data statement were in most cases historical in nature, but in some cases estimated.

Criteria against which verification was conducted:

- World Resources Institute (WRI)/World Business Council for Sustainable Development (WBCSD) GHG Protocol Corporate Accounting and Reporting Standard (Scope 1 and 2)

Reference Standard:

- ISO 14064-3 Second Edition 2019-04: Greenhouse gases -- Part 3: Specification with guidance for the verification and validation of greenhouse gas statements

Level of Assurance and Qualifications:

- Limited
- This verification used a materiality threshold of $\pm 5\%$ for aggregate errors in sampled data for each of the above indicators.

GHG Emissions and Electricity Consumption Data Verification Methodology:

Evidence-gathering procedures included but were not limited to:

- Interviews with relevant personnel of Toast and their consultant;
- Review of documentary evidence produced by Toast and their consultant;
- Review of Toast data and information systems and methodology for collection, aggregation, analysis and review of information used to determine GHG emissions and electricity consumption data; and
- Audit of sample of data used by Toast to determine GHG emissions and electricity consumption data.

Verification Opinion:

Based on the process and procedures conducted, there is no evidence that the GHG emissions and electricity consumption data statement shown above:

- is not materially correct and is not a fair representation of the GHG emissions and electricity consumption data and information; and
- has not been prepared in accordance with the WRI/WBCSD GHG Protocol Corporate Accounting and Reporting Standard (Scope 1 and 2).

It is our opinion that Toast has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these GHG emissions and electricity consumption data for the stated period and boundaries.

Statement of independence, impartiality and competence


