# CI Financial Reports Total Assets of \$420.7 Billion for October 2023

TORONTO--(BUSINESS WIRE)-- **CI Financial Corp.** ("CI") (TSX: CIX) today reported preliminary total assets of \$420.7 billion as at October 31, 2023, consisting of asset management assets of \$117.1 billion, Canadian wealth management assets of \$80.7 billion, Canadian custody assets of \$23.4 billion, and U.S. wealth management assets of \$199.4 billion.

As previously announced, CI completed the acquisition of Windsor Wealth Management Inc., an Indianapolis-based registered investment advisor, in October.
