TORONTO--(BUSINESS WIRE)-- **CI Financial Corp.** ("CI") (TSX: CIX) today reported preliminary total assets of \$467.9 billion as at April 30, 2024, consisting of asset management assets of \$126.8 billion, Canadian wealth management assets of \$92.3 billion, Canadian custody assets of \$27.7 billion, and U.S. wealth management assets of \$221.2 billion.
