CI Financial Reports Total Assets of \$525.3 Billion for October 2024

TORONTO--(BUSINESS WIRE)-- **CI Financial Corp.** ("CI") (TSX: CIX) today reported preliminary total assets of \$525.3 billion as at October 31, 2024, consisting of asset management assets of \$136.1 billion, Canadian wealth management assets of \$100.4 billion, Canadian custody assets of \$32.3 billion, and U.S. wealth management assets of \$256.5 billion.

As previously reported, on October 31, 2024, Corient, CI's U.S. wealth management subsidiary, completed the acquisition of registered investment advisor Ensemble Capital Management, LLC of San Francisco, adding assets of approximately \$2.4 billion (US\$1.8 billion).
