

CI Financial Reports Total Assets of \$532.7 Billion for November 2024

TORONTO--(BUSINESS WIRE)-- **CI Financial Corp.** ("CI") (TSX: CIX) today reported preliminary total assets of \$532.7 billion as at November 30, 2024, consisting of asset management assets of \$140.1 billion, Canadian wealth management assets of \$103.2 billion, Canadian custody assets of \$34.5 billion, and U.S. wealth management assets of \$254.9 billion.

Corient, CI's U.S. wealth management subsidiary, sold its investment in OCM Capital Partners LLC on November 8, 2024, reducing U.S. wealth management assets by approximately \$10.1 billion (US\$7.2 billion).
