CHICAGO--(BUSINESS WIRE)--Jul. 20, 2012-- The board of directors of GATX Corporation (NYSE:GMT) today declared a quarterly dividend of \$0.30 per common share, payable September 30, 2012, to shareholders of record on September 14, 2012. This quarterly dividend is unchanged from the prior quarter.

The board also declared a quarterly dividend of \$0.625 per share on the \$2.50 preferred stock, payable September 1, 2012, to shareholders of record on August 15, 2012, unchanged from the previous quarter.
