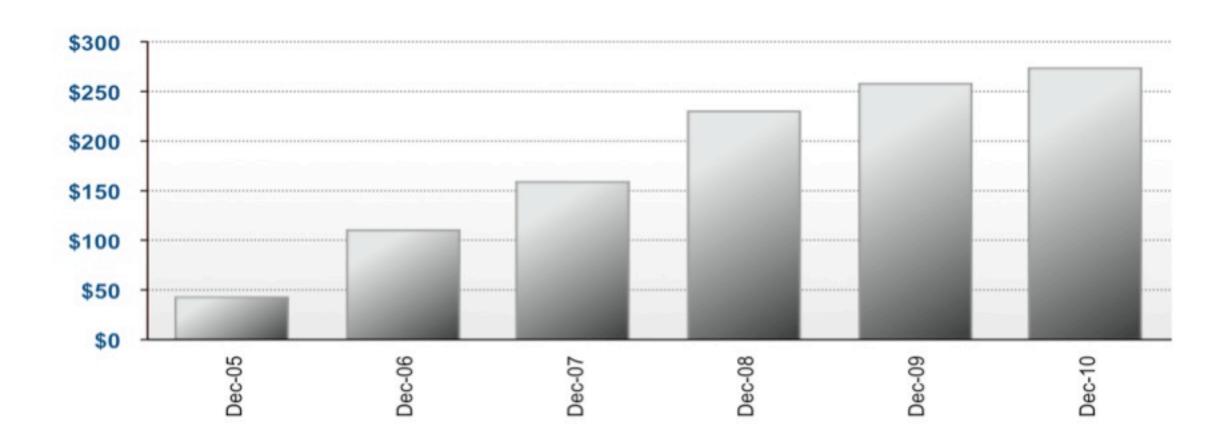

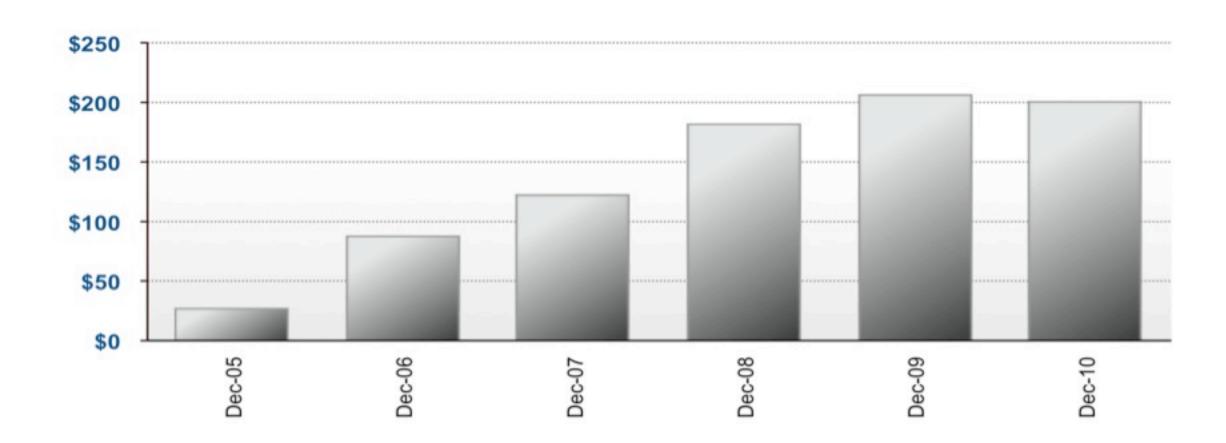


Total Consolidated Assets

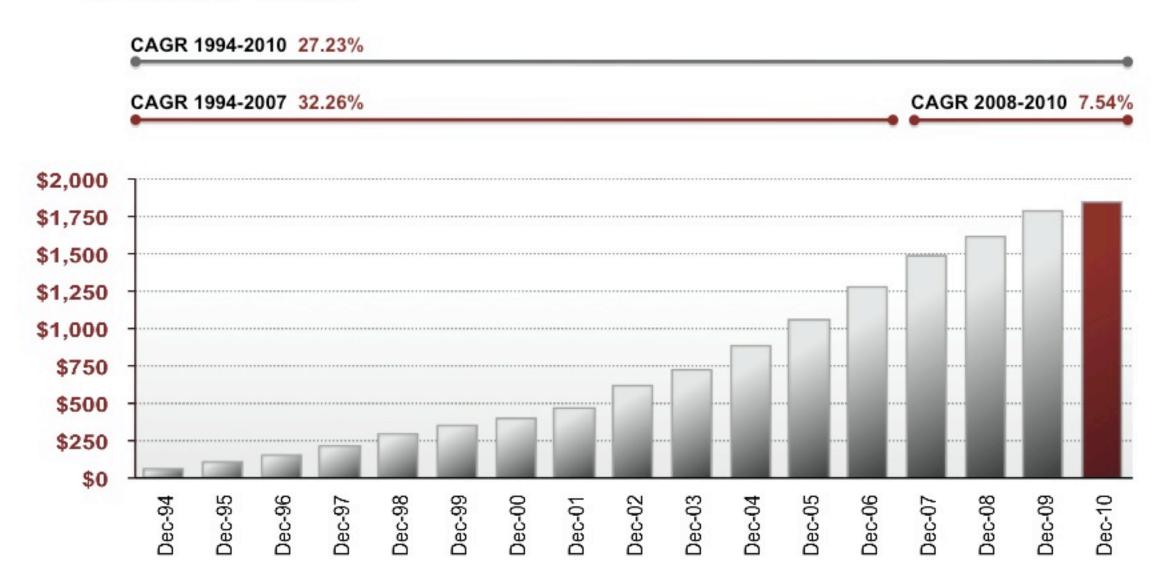

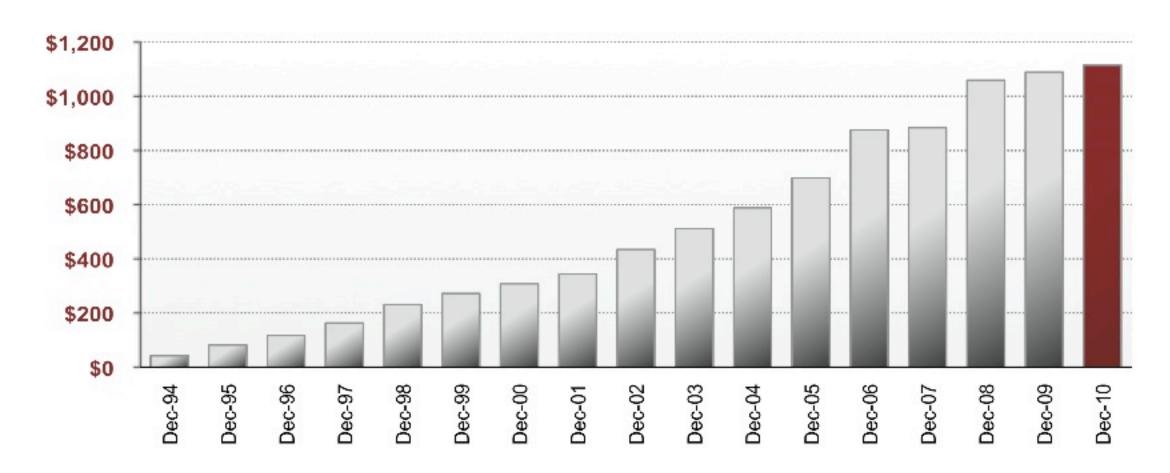


Total Consolidated Assets



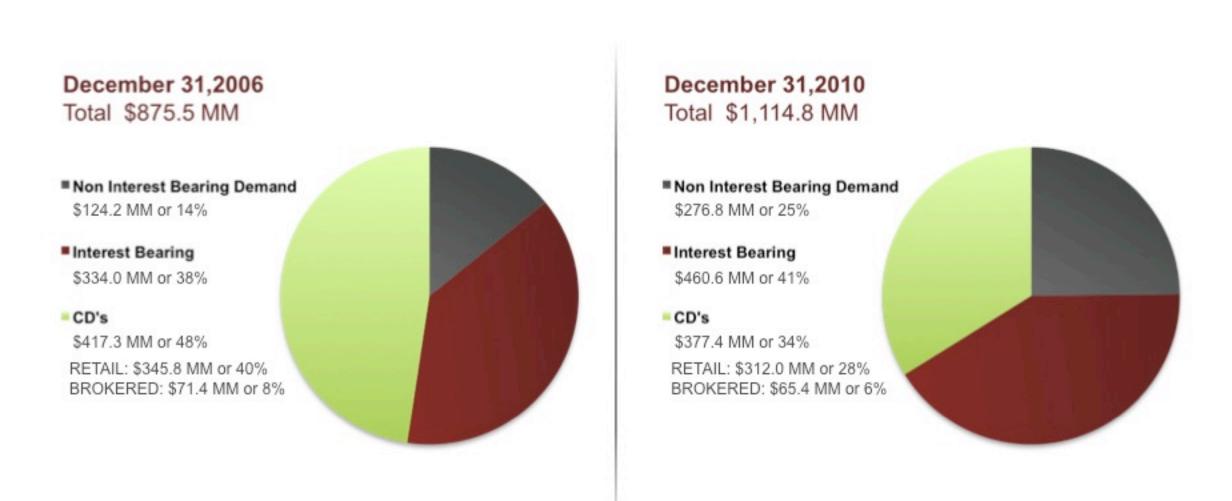


Total Consolidated Deposits





A Closer Look: Total Consolidated Deposits (2006 vs. 2010)





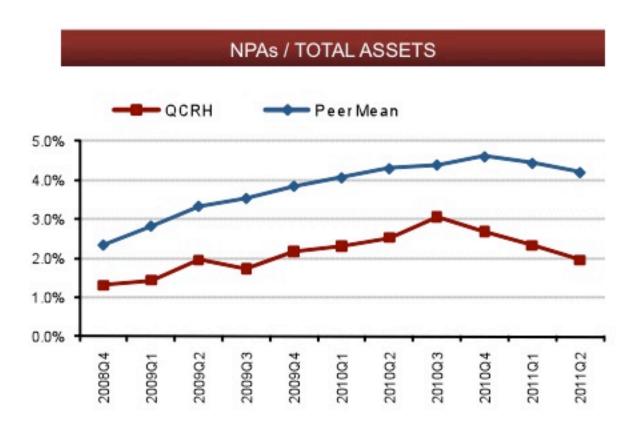

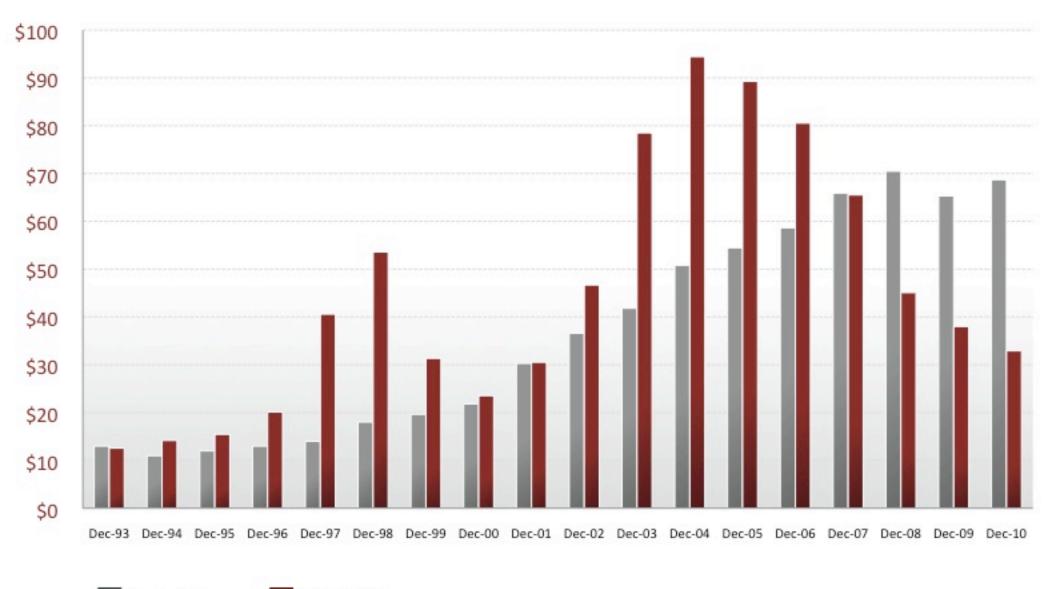

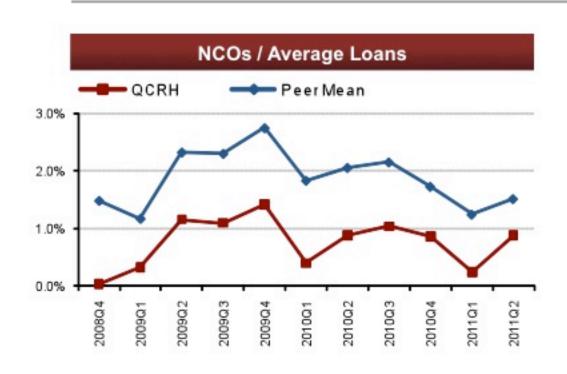

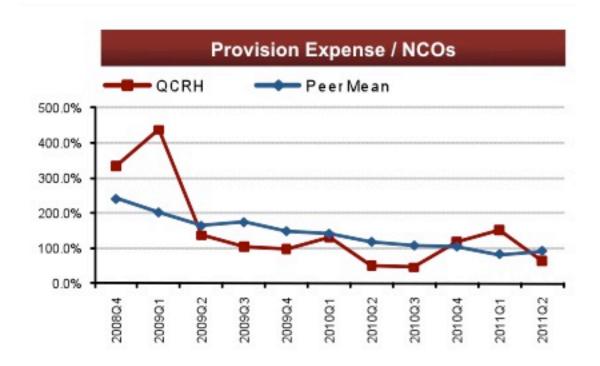

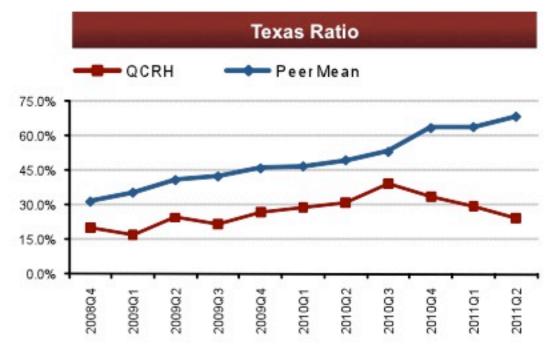


Peer Credit Analysis Graphs
